



Order of the Industrial Estate Authority of Thailand

Re: The Appointment of the Cooperation Committee for Participation in Upgrading  
the WHA Eastern Seaboard Industrial Estate 1 to Eco-industrial Town

Reference is made to the Order of the Industrial Estate Authority of Thailand No. 192/2562 Re: The Appointment of the Cooperation Committee for Participation in Upgrading the WHA Eastern Seaboard Industrial Estate 1 to Eco-industrial Town, dated 18 June 2019, and where the manual, criteria, indicators, and audit criteria to support the eco-industrial town have established the structure and responsibilities of the Cooperation Committee for participation in the improvement of industrial estates to eco-industrial towns that the directors appointed from outsiders have a term of office not exceeding two years from the date of their appointment.

By virtue of Section 28 of the Industrial Estate Authority of Thailand Act, B.E. 2522, therefore, the aforementioned order is repealed, and the Cooperation Committee is formed to participate in the upgrade of the WHA Eastern Seaboard Industrial Estate 1 to Eco-industrial Town. The composition, duties, and authorities of the Cooperation Committee are as follows:
