

Order of the Industrial Estate Authority of Thailand No. 138/2565 Re: Appointment of the Environmental Monitoring and Community Relations Committee for WHA Eastern Seaboard Industrial Estate 3 Project

To ensure that environmental monitoring of the WHA Eastern Seaboard Industrial Estate 3 Project is conducted efficiently and in accordance with preventative and corrective measures for environmental impacts and monitoring measures for environmental impacts, the Environmental Monitoring and Community Relations Committee, comprised of government representatives, community representatives, and project representatives, is thus formed. The Committee shall engage in governance and offer recommendations on the project's implementation and integrated problem-solving strategies.

By virtue of Section 28 of the Industrial Estate Authority of Thailand Act, B.E. 2522, the Environmental Monitoring and Community Relations Committee for WHA Eastern Seaboard Industrial Estate 3 Project is thus formed, with the following composition, duties, and authorities:

The term of office for the Committee is 4 years, and no more than two consecutive terms may be served. In the first term of office, the Committee shall convene a meeting to elect the Chairman, Vice Chairman and Secretary of the Committee.

- 2. Duties and Authorities
 - 2.1 Educate and organize trainings for the community to recognize and understand about environmental pollution from project activities and communicate to the community for acknowledgment and understanding of how to observe abnormalities in environmental quality from project activities and the reporting process to respond promptly to abnormalities
 - 2.2 Conduct project visits to comprehend the environmental quality measurement process and its results to demonstrate transparency in the project's environmental management
 - 2.3 Analyze the trends in the environment quality situation surrounding the project
 - 2.4 Participate in consultation and determination of guidelines for the prevention and resolution of environmental and health-related issues
 - 2.5 Resolve conflicts and disputes and consider compensation in terms of examination, timing, and forms of compensation in addition to what prescribed by the law if it can be demonstrated that the project caused harm to life and property, including crops, animals, or other property
 - 2.6 Evaluate the efficacy of environmental and health impact monitoring at least once a year to ensure that working styles and procedures are suitable for varying yearly scenarios
 - 2.7 Provide guidance, recommend guidelines, and coordinate with the community, as well as communicate project information to the community surrounding the project
 - 2.8 Participate in consultations, including the exchange of information, to monitor the implementation and resolving issues between the project, the community, and agencies for efficiency and achievement
 - 2.9 Contribute to the community and social development projects for the communities surrounding the project site and offer suggestions for enhancing the project so that it is appropriate in terms of economy, society, environment, and community health
 - 2.10Examine the complaint handling process in previous projects and provide comments and suggestions to improve the management of complaints

2.11The Committee may appoint a person or group of persons to carry out ad hoc operations necessitated by the project's development.

This shall, thus, become effective henceforth.
